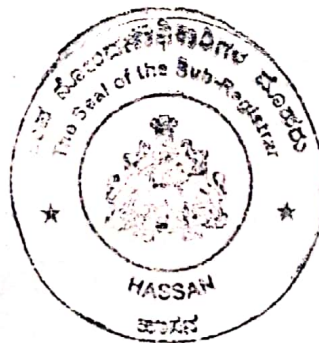



4. To establish manage, maintain and to develop yoga schools, Ayurvedic and Homeopathic institutions, prayer halls, community halls etc.,

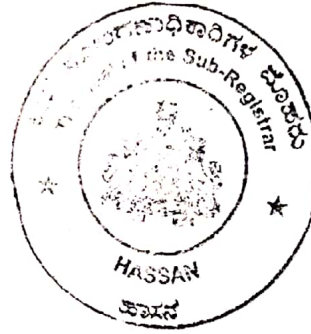

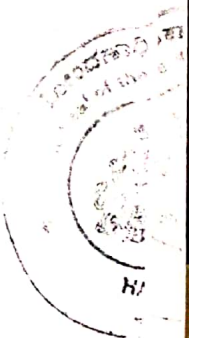

7. For achieving any or all the objects to raise funds, through donations, grants, gifts, sachet and contributions and to obtain and receive the interest free loans from individuals, associations, firm or any institutions.
8. To acquire by way of/ way purchase/lease/mortgage/loans/gift/grant /legacy/bequest exchange rights, privileges or otherwise from any persons, company, society, government institutions, organizations or any body whatsoever moveable or immovable properties of all descriptions deemed necessary or useful for the purpose of achieving the object of the trust.
9. To invest the funds of the trust in the securities under the provisions of sec.13 (1) D/r/w.sec.13 (5) of the Income Tax Act 1961.
- 10.To invest money of the trust in such investments as permissible under the Income Tax Act 1961 and the rules they are under as they stand from time to time.
- 11.To invest funds immediately required in such a manner as may be determined by the board of trustees from time to time.
- 12.To cancel, recall or vary all or any of the investments from time to time.

MANAGEMENT OF THE TRUST:

a) The above said four persons shall be the permanent trustees constituting the board of trustees who shall manage the affairs of the trust and they shall hold the office for life.

QUORUM:-

For any regular meeting the presence of live permanent trustees shall be the quorum.

POWER AND DUTIES:-

a) PRESIDENT:-

(i) The president of the Trust shall preside over all the meetings of the Trust. He shall have the power to invite any person or persons other than Trustees to attend any of the meetings of the Board of the Trustees.

(ii) They may co-opt additional trustees and determine the terms of their appointment but additional trustees and determine the terms of their appointment but failure to nominate such trustees or trustees shall invalidate the trust of any action taken by the permanent trustees.

(iii) If in the opinion of the majority of the permanent trustees, activities or conduct of any trustee including the permanent trustees is against the interest of the trust, the trusteeship of such a trustee is determined to be against the interest of the trust, the trusteeship of such a trustee can be terminated.

d) TREASURER:-

The Treasurer shall receive and distribute the moneys of the Trust and maintain or cause to be maintained proper account of the Trust and get it audited annually from 1st April to 31st March. All ligancies, donations and subscriptions shall be paid to the Treasurer, whose receipt shall be valid and binding on the trust.

e) BOARD OF TRUSTEES:-

1. The board of trustees shall meet as often as necessary or at least once in every three months, and proceedings shall be recorded regularly in the minute's book to be maintained for the purpose.
2. Any resolution which regard to the administration of the Trust shall be passed by the majority of Trustees present and Voting. In case being equal on the issues, the president of the meeting shall have the casting vote for the purpose of deciding the issues.
3. The trustees may receive subscription donations, contributions and gifts of money and/or properties which shall be absolute property of the Trust.
4. The trustees shall invest the properties, money and other asstes of the Trust in such a manner, as they may deem fit proper in furtherance of the objects of the Trust.
5. The Trustees may frame rules and regulations as to the duties and responsibilities of each Trustees to appoint sub-committees for carrying out any the activities and matters connected with the administration of the trust and its management.
